President Orders U.S. Flags to Half-Staff

**HONORING THE VICTIMS OF THE ATTACK IN SAN BERNARDINO,  
CALIFORNIA**

**BY THE PRESIDENT OF THE UNITED STATES OF AMERICA**

**A PROCLAMATION**

As a mark of respect for the victims of gun violence perpetrated on December 2, 2015, in San Bernardino, California, by the authority vested in me as President of the United States

by the Constitution and the laws of the United States of America, I hereby order that the flag of the United States shall be flown at half-staff at the White House and upon all public buildings and grounds, at all military posts and naval stations, and on all naval vessels of the Federal Government in the District of Columbia and throughout the United States and its Territories and possessions through December 7, 2015.

I also direct that the flag shall be flown at half-staff for the same length of time at all United States embassies, legations, consular offices, and other facilities abroad, including all military facilities and naval vessels and stations.

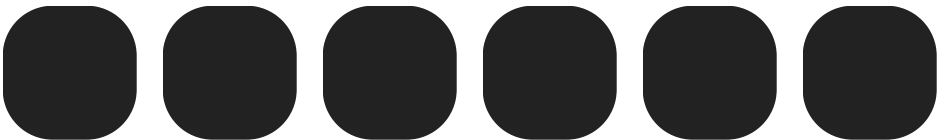

City's Holiday Schedule:

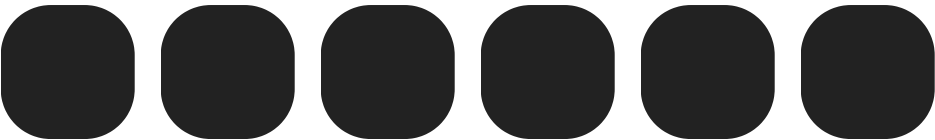

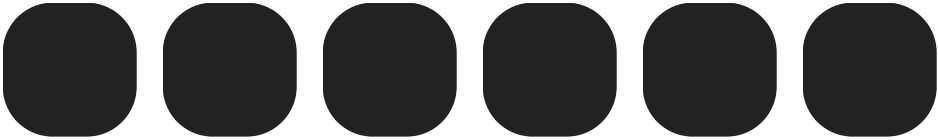
