Saint Francis Adds to Emergency Department

Cape Girardeau, Missouri - Saint Francis Medical Center welcomes emergency medicine specialists Charles Dodson, DO, FACEP, and Martin Blake, MD, as new providers in the Emergency Department. 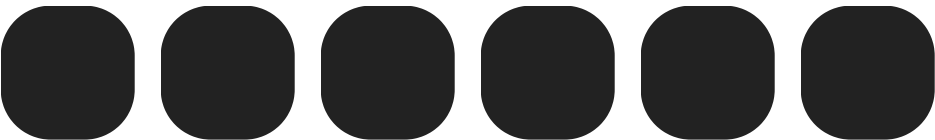

Weather permitting, work will be performed Tuesday, April 3 through Wednesday, April 4 from 6 a.m. to 4:30 p.m. daily.

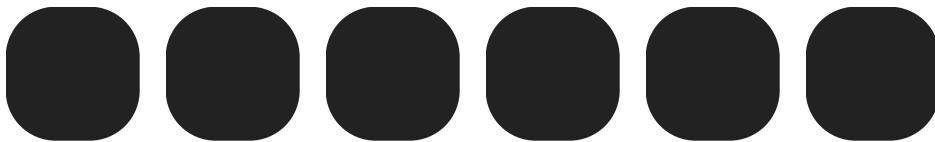
The work zone will be marked with signs. Motorists are urged to use extreme caution while traveling near the area.
