*"The Red Ribbon Campaign is the largest drug-abuse prevention campaign in the United States. Since its beginning in 1985, the Red Ribbon has touched the lives of millions of people around the world. In response to the murder of DEA Agent Enrique Camarena, angered parents and youth in communities across the country began wearing Red Ribbons as a symbol of their commitment to raise awareness of the killing and destruction cause by drugs in America.*

*Enrique (Kiki) Camarena was a Drug Enforcement Administration Agent who was tortured and killed in Mexico in 1985. When he decided to join the US Drug Enforcement Administration, his mother tried to talk him out of it. "I'm only one person", he told her, "but I want to make a difference."*

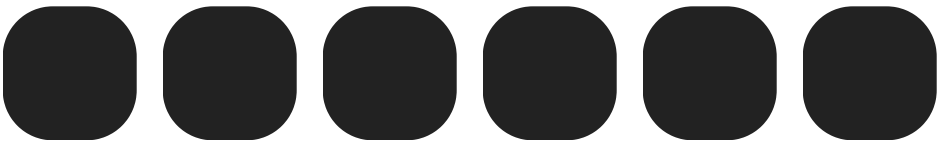
*On Feb. 7, 1985, the 37-year-old Camarena left his office to meet his wife for lunch. Five men appeared at the agent's side and shoved him in a car. One month later, Camarena's body was found. He had been tortured to death.*

*In honor of Camarena's memory and his battle against illegal drugs, friends and neighbors began to wear red badges of satin. Parents, sick of the destruction of alcohol and other drugs, had begun forming coalitions. Some of these new coalitions took Camarena as their model and embraced his belief that one person can make a difference. These coalitions also adopted the symbol of Camarena's memory, the red ribbon."*

## PUBLIC CHILD FIND NOTICE

Stoddard & Bollinger County Schools

### **PUBLIC CHILD FIND NOTICE**

All responsible public agencies are required to locate, evaluate, and identify children with disabilities who are under the

jurisdiction of the agency, regardless of the severity of the disability, including children attending private schools, children who

live outside the district but are attending a private school within the district, highly mobile children, such as migrant and

homeless children, children who are wards of the state, and children who are suspected of having a disability and in need of

special education even though they are advancing from grade to grade. The public school districts listed assure that it will

provide a free, appropriate public education (FAPE) to all eligible children with disabilities between the ages of 3 and 21 under

its jurisdiction. Disabilities include autism, deaf/blindness, emotional disorders, hearing impairment and deafness, intellectual

disability, multiple disabilities, orthopedic impairment, other health impairments, specific learning disabilities, speech or

language impairment, traumatic brain injury, visual impairment/blindness and young child with a developmental delay. The

public school districts listed assure that it will provide information and referral services necessary to assist the State in the

implementation of early intervention services for infants and toddlers eligible for the Missouri First Steps program. The public

school districts listed assure that personally identifiable information collected, used, or maintained by the agency for the

purposes of identification, evaluation, placement or provision of FAPE of children with disabilities may be inspected and/or

reviewed by their parents/guardians. Parents/guardians may request amendment to the educational record if the parent/guardian

believes the record is inaccurate, misleading, or violates the privacy or other rights of their child. Parents have the right to file

complaints with the U.S. Department of Education or the Missouri Department of Elementary and Secondary Education

concerning alleged failures by the district to meet the requirements of the Family Educational Rights and Privacy Act (FERPA).

The public school districts listed have developed a Local Compliance Plan for the implementation of State Regulations for the

Individuals with Disabilities Education Act (IDEA). This plan contains the agency's policies and procedures regarding storage,

disclosure to third parties, retention and destruction of personally identifiable information and the agency's assurances that

services are provided in compliance with the General Education Provision Act (GEPA).

This notice will be provided in native languages as appropriate.

## **504 PUBLIC NOTICE**

The Public School Districts listed, as a recipient of federal financial assistance from the United States Department of Education

and operates a public elementary or secondary education program and/or activity, is required to undertake to identify and locate

every qualified person residing in the District who is not receiving a public education; and take appropriate steps to notify

disabled persons and their parents or guardians of the District's duty.

These Public School Districts assure that they will provide a free appropriate public education (FAPE) to each qualified

disabled person in the District's jurisdiction regardless of the nature or severity of the person's disability. For purposes of

Section 504 of the Rehabilitation Act of 1973, the provision of an appropriate education is the provision of regular or special

and related aids and services that (i) are designed to meet individual educational needs of disabled persons as adequately as the

needs of nondisabled persons are met and (ii) are based on adherence to procedures that satisfy the requirements of the 504

federal regulations. These Public School Districts have developed a 504 Procedures Manual for the implementation of federal

regulations for Section 504 of the Rehabilitation Act, Subpart D.

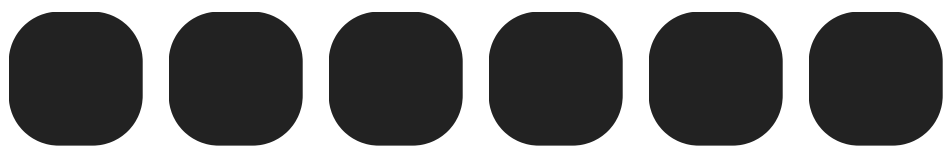

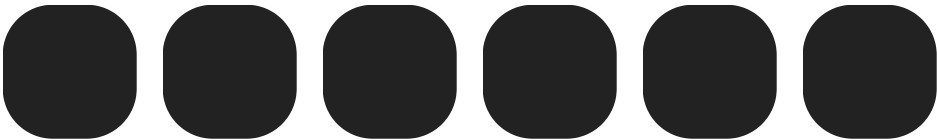

The ShowMe Times will hopefully film the coronation on October 22nd to be put on Facebook later that morning.

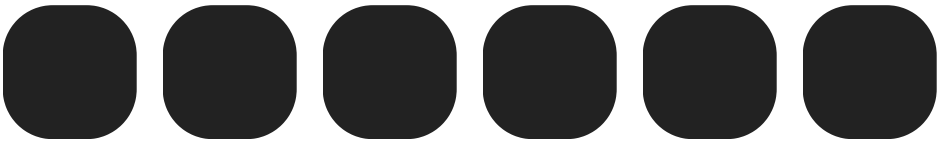
