The family respectfully requests that everyone wear a mask.

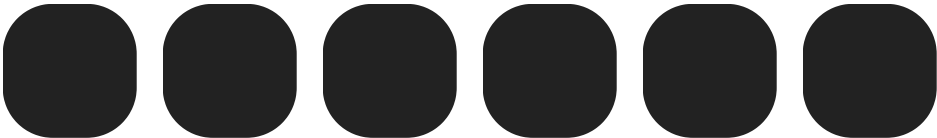
