Myra had been a resident of Stoddard County, Missouri all of her life. She was of the Baptist faith and enjoyed attending Church.






Other than by his parents, he was preceded in death by his son, Anthony Reeves, and by two sisters, Linda Abney, and Anna Belle Pratt.
