U.S. 60 ADA Sidewalk Improvements in Stoddard County

U.S. 60 ADA Sidewalk Improvements in Stoddard County

U.S. Route 60 will be reduced to one lane with a 10-foot width restriction as contractor crews improve sidewalks in Dexter, Missouri. This project is part of the Missouri Department of Transportation's initiative to bring roadway facilities into compliance with the current standards of the Americans with Disabilities Act (ADA).

Contractor crews will improve sidewalks between North Mulberry Street and Route 25.

Weather permitting, work will take place Monday, Dec. 13 through Monday, Jan. 31, 2022 from 6 a.m. to 6 p.m. daily.

The work zone will be marked with signs. Motorists are urged to use extreme caution while traveling near the area.


