### Stoddard County Republican Caucus March 2, 2024, Only Opportunity to Vote for Nominee for President

Stoddard County Republican Caucus March 2, 2024, Only Opportunity to Vote for Nominee for I

For the first time since the 1990s a caucus will be held in Missouri. What does that mean? If you are Republican and want to choose your candidate for the November election you will need to attend this caucus and place your vote. There will be no Presidential primary in Missouri this year!

"The caucus will be held at the Bearcat Event Center on Saturday, March 2nd," commented Chairman of the Stoddard County Republican Central Committee Wayne Jean. "The doors will open as early as 7:30 a.m. Participating in this caucus could take a couple of hours."

Jean said on the day of the caucus people will enter the doors of the BEC and there will be registration tables set up just like an election. At each table there will be an individual with a computer. The caucus participant will check a box indicting they are a registered voter in Stoddard County and check a box indicating they are Republican.

#### A photo ID is required to register!

Your name will be matched against a list of registered voters in Stoddard County. The list is from the Stoddard County Clerk's Office. Jean also commented that if the voter has not participated in the past few elections their name will not appear on this list.

Once registered, the participant will be asked to go to the BEC gym, sit in the bleachers, and wait for the caucus to begin.

The caucus will begin promptly at 10:00 a.m. The doors will be closed and no one else will be allowed in the BEC. Jean said that people should show up early as it will take a few minutes to register. The Pledge of Allegiance and an invocation will take place. A chairman will then be elected to run the caucus.

Participants in the gym will be separated into groups. If you are wishing to vote for Donal Trump," commented Jean. "You will be asked to move to a confined areas of the gym. If you support another candidate you will be separated for that candidate in a contained area and so forth." There could be more than one group.

Each group will then elect a chairman or spokesperson for their group. A count of the number of people in each group will take place. Each group that does not have more than 15% of the total number of participants in attendance will have to disband. Those individuals can then go home or join another group. Ultimately there will be one group left and this will be the candidate to receive Stoddard County's votes.

Delegates must also be elected at the caucus.

Delegates and alternates will then go to the congressional caucus on April 6th. It is possible the delegates would also be elected to attend the State Convention on May 4th at the Springfield Expo Center. The National republican Convention will be in July in Milwaukee. Delegates will travel at their own expense.

"This will be the only opportunity to vote for who the Republican nominee for President will be," stated Jean. "This does not affect a voters ability to vote in the general election in November. Though attendance is encouraged if a voter does wish to participate in the caucus."

### Circuit Judge Robert N. Mayer Announces Reelection Bid

Circuit Judge Robert N. Mayer Announces Reelection Bid

Judge Rob Mayer has announced his intentions to seek reelection as the Thirty-Fifth Circuit Judge in Dunklin and Stoddard Counties.

"Twelve years ago, I promised to apply the law fairly, consistently and impartially. We have created a record of doing that here in this circuit," Mayer said. "My experience as an attorney and serving in the legislature put me in a unique position to serve Dunklin and Stoddard counties in the judicial branch. As a judge, I have worked to interpret the law as written and apply the law fairly, consistently, and impartially."

Mayer grew up working on his family's farm and was a radio sportscaster covering high school sports – a hobby he still enjoys. He later worked as an industrial engineering clerk at Arvin Automotive in Stoddard County before returning to college and law school later in life. Rob is a graduate of Dexter High School. He received his undergraduate degree from Southeast Missouri State University and a Juris Doctorate from the University of Missouri-Kansas City.

As a legislator, Rob Mayer gained a reputation as a leader on many important issues. Mayer has a strong legislative record on pro-life issues. He has also advocated for the expansion of private property rights throughout his service in the legislature.

In the State House of Representatives, Mayer served as Chairman of the House Crime Prevention Committee for two years, passing important bills to fight the methamphetamine drugs epidemic and create Missouri's Amber Alert System. In the Missouri Senate, Mayer served as Vice Chairman of the Senate's Judiciary Committee and passed legislation protecting children from sex offenders and implementing Megan's Law to protect our youth from cyberbullying.

In addition, Mayer has received the American Legion Legislator of the Year Award, the 2010 Spirit of Enterprise Award from the Missouri Chamber of Commerce, the MPCA Champion of Community Health Award, the Voice of Missouri Business Award and the Farm Bureau Friend of Agriculture Award.

Mayer was elected unanimously by both Democrat and Republican members of the Missouri Senate to serve as the first President Pro Tem of the Missouri Senate from the bootheel.

"My experience farming, working in a factory, raising a family, and serving as an attorney assisting families and businesses has given me a well-rounded life experience," Mayer said. "I have always been a citizen's lawyer, and as a judge I have worked very hard for the people in our community."

Judge Mayer has presided over numerous jury trials and has willingly accepted assignments outside of the Thirty-Fifth Circuit. In 2013-14, he oversaw the implementation of electronic filing and electronic recordkeeping for Stoddard and Dunklin Counties and later administered the Municipal Court Operating Standards for the municipalities within the district. He has conducted thousands of review hearings with all probationers within his court to assist them in meeting their

probation conditions of treatment, employment, and payment of restitution. For defendants suffering from alcohol or drug addiction, Judge Mayer has been a big proponent of referring them to Treatment Court or into faith-based rehabilitation programs with positive results.

Judge Mayer has been honored for his work as a judge by the Missouri Supreme Court by receiving, on multiple occasions, the Daniel O'Toole Award for efficient case management.

Rob and his wife, Nancy (Tuley) Mayer, live in Dexter. They have three sons: Jason, Dustin and Daniel; and also, six grandchildren.

Mayer is active in many community and regional activities. He is a member of the Dexter First Baptist Church, Missouri Farm Bureau, the Stoddard County Bar and Missouri Bar Associations, Dexter Kiwanis Club, Stoddard County Gospel Mission Board, Missouri Delta Center Advisory Member, and previously served on the Missouri Veterans Home Foundations Board.

"I am proud of my record," Mayer said, "but we still have more to do. I have a good working relationship with the bailiffs and court clerks, and we have worked hard to run our courts efficiently. I would be honored to continue serving as Circuit Judge and will continue to apply the law fairly, consistently, and impartially.
